AT and T

At and T is advertising free service for the first two months (if you access before May 23rd) and then \$5.00 or \$10.00 a month after that. Please verify this information.

There may be a charge to rent a modem (\$15 dollars per month).

I do not see any phone help.

ComCast

They are advertising two months free. Then, the cost is \$9.99 plus tax. (I believe the modem is included.).

Dear Parent/Guardian:

Your application for free and reduced-price meals has been **APPROVED for FREE meals** based on **DIRECT CERTIFICATION** at Sequoia High School during the 2019-2020 school year.

To receive meal benefits, your high school student will need to go to a serving area and use the Personal Identification Number or PIN shown below. This PIN will allow your child to access his/her account and be served a free or reduced price meal. Reduced price breakfast is 30 cents per meal and reduced price lunch is 40 cents per meal. Prepayment is available for reduced price meals. Breakfast and lunch are available every school day a serving area.



Meal Benefits Expiration Date: **09/30/2020**

You may reapply for free or reduced price meal benefits anytime during the school year. If your income goes down, your family size gets larger, or you begin to receive Food Stamp (FS), California Work Opportunity (CalWORKs), Kinship Guardian Assistance Payment (KinGAP), or Food Distribution Program on Indian Reservations (FDPIR) benefits, you may submit an application at that time.

If you have any questions concerning this decision, please contact the Food Service office at the address or phone number listed above to discuss it informally. You also have the right to request a hearing to appeal the decision. If your appeal is filed within ten days after the date of this letter, benefits will continue until the appeal is settled.
